

## Registration for Exams in the Winter Semester 2019/20

### *Taking exams in the MAIR: Some ground rules*

- To complete a module and to obtain the assigned credits you have to take and pass a number of (partial) exams in the widest sense, such as oral presentations, take-home or in-class exams, and various kinds of shorter or longer papers.<sup>1</sup>
- Taking exams, in turn, presupposes that you register for the module via PABO in the semester in which you are taking the exams. This is true of postponed or makeup exams as well: if, for example, you started a module in the winter semester (taking some of the partial exams but not all of them) but finish it only in the subsequent summer semester (by taking the remaining exams), you have to make sure you register for the module (again) in the summer term.
- In every semester, there is only a certain period of time in which you can register for an exam or cancel a prior registration should you change your mind (“Add/drop period”). This period is not the same for all modules but to some extent “module-specific”.<sup>2</sup>

Here are the **add/drop periods** for the current winter semester:<sup>3</sup>
